Accelerating Higher Education Expansion and Development (AHEAD) Operation ELTA-ELSE DEPARTMENT DP – Department of Tourism Studies

Consultancy for Software, Catalogue and Database Development (UWU/AHEAD/ELTAELSE/DTS/CON/02)

Department of Tourism Studies (DTS), Uva Wellassa University (UWU)

1. Background

The development of the higher education sector is of central importance to enable Sri Lanka to make the transition from a Lower Middle Income Country (LMIC) to an Upper Middle Income Country (UMIC). Recognizing this, the Government of Sri Lanka (GoSL) and the World Bank have agreed, to support the higher education sector through a Bank funded Accelerating Higher Education Expansion and Development (AHEAD) operation.

The Department of Tourism Studies (DTS) was initiated on May, 2019 as the 4th academic department of the Faculty of Management (FOM) and BBM in Hospitality, Tourism & Events Management degree programme which was initiated in 2009 in the faculty (and was under the administration of Department of Public Administration) was transferred to the department at the inception. During its short existence, the DTS has taken steps to incorporate the principles of Outcome Based Education and Learner Centred Teaching into its degree programme. Further, the department has taken initiatives to enhance the necessary socio emotional skills of undergraduates while promoting research culture in the department in order to enhance the career related skills and employability of undergraduates.

Under the Accelerating Higher Education Expansion and Development (AHEAD) Operation, the DTS has identified the following five activities.

- Activity 1: Promoting research culture within the students and staff of the department
- Activity 2: Enhancing event catering skills of the HTE undergraduates
- Activity 3: Developing tour guiding skills of the HTE undergraduates
- Activity 4: English language skills enhancement of undergraduates through creative practices
- Activity 5: Increasing the employability opportunities and job fitness of HTE students

Under the Activity 5 – Increasing the employability opportunities and job fitness of HTE students, a career cruising platform was proposed in order to increase the industry linkages of undergraduates that lead to strengthen students' self-exploration and planning to develop their career goals.

The DTS aims to produce graduates that fit to the industry requirements who can sustain in any working environment in the competitive arena. However, due to the locational disadvantage and less attraction from the industry towards graduates, the graduates of HTE degree programme of DTS have a huge challenge in developing industry linkages throughout their study period. Hence, finding industrial training placements has become a due responsible of the industrial training coordinator of the department. Further, the students have very rare opportunities in earning extra money while they are studying in the university as

well as see the real picture of the continuously growing industry during the undergraduate life.

Hence, the proposed online Career Cruising Platform is expected to develop a bridge between the industry and undergraduates/ graduates connecting students and industry profiles to share information about the world of work to make ready the undergraduates to that world.

Proposed career cruising platform will support students to;

- a. learn about organizations that offer jobs and available careers in their area of interest
- b. participate in career discussions with an online career coach from selected companies
- c. interact with the organizations relevant to the field of study through different career learning experiences, such as job-shadowing, internships, company tours, and part time employments, etc.

Undoubtedly, the current classroom sessions with heavy theoretical background are insufficient to produce a manager fitting to the industry needs with required qualities. To conquer this challenge, the Career Cruising Platform has been proposed as a solution of facilitating the necessary atmosphere for the undergraduates meaningfully.

In order to initiate this activity, an online Career Cruising Platform need to be developed and it is important to hire a professional to prepare this platform in consultation with the department prepared in consultation with academics and industry experts, who will be lecturers in the faculty. Accordingly, this TOR is meant for a Consultant for developing an online Career Cruising Platform for the HTE undergraduates.

2. The Operation

Accelerating Higher Education Expansion and Development (AHEAD) operation is organized into two components. The first is a Program Component that supports the national Higher Education Development Program. The second is a systems strengthening, capacity building and technical assistance component that will assist GoSL to strengthen the higher education sector and achieve the objectives of the AHEAD program component. This second will also cover monitoring and evaluation, policy analyses, program coordination and communication.

The implementing agency is the Ministry of Higher Education and Highways (MHEH). The University Grants Commission (UGC) will coordinate the activities of the universities. There will be an Operations Monitoring and Support Team (OMST) which will coordinate and support all AHEAD activities between the MHEH, UGC, and the universities.

AHEAD has three Results Areas:

Results Area 1: Increasing Enrollment in Priority Disciplines for Economic Development

Results Area 2: Improving the Quality of Higher Education

Results Area 3: Promoting Research, Development and Innovation

3. Objectives of the Consultancy

 To develop a workable Online Career Cruising Platform that links undergraduates of DTS and related organizations in the industry with the necessary facilities for career cruising

4. Scope of the Consultancy

The target group of the career counselling platform will be all the undergraduates of DTS and various industry stakeholders in the fields of hospitality, tourism, and events. Hence, the number of users of the platform will be higher with the time. The selected Consultant is expected to develop the platform in order to achieve the expected outcomes given below.

Through a successful use of career cruising platform, the students should be able to:

- a. Enhance the awareness on available career opportunities in the industry
- b. Enrich the job fitness
- c. Upload the student's resume and track records to make aware the focused industry stakeholders on individual's performance
- d. Participate in career discussions with an online career coach from selected companies
- e. Interact with the organizations relevant to the field of study
- f. Improve the career focused skills through different career learning experiences, such as job-shadowing, internships, company tours, and part time employments, etc.

5. Key Tasks and Related Activities

The key tasks of the Consultant will be to:

- Develop the structure of the expected website in consultation with the lecturers, and students in the department and the comments of industry stakeholders
- Develop the Career Cruising Website and testing
- Complete the website with necessary modifications and launching
